Licence terms and conditions

By submitting a manuscript to the Acta Musealia journal for review, the author grants the Museum of the Moravian Wallachia region, c. o. and the Museum of South East Moravia in Zlín, c. o. a licence to use the contribution under the conditions specified below:

Statement of the author

The author declares that the manuscript is free from copyright or other legal defects. The manuscript is the author's original work and has not been previously published, including in another language. The manuscript has not been offered for publication elsewhere at the same time as it is offered to Acta Musealia. The only exceptions are platforms that allow pre-publication scholarly communication (e.g. ResearchGate, Academia).

- The author claims to be the real author of the submitted manuscript. Therefore, the author is not restricted in any way in granting the licence, and his or her freedom to grant the licence is not restricted or excluded in any way, i.e. the author is free to use the manuscript as he or she sees fit. The lead author also declares that all co-authors agree to the wording of these licence terms and to the latest submitted form of the manuscript.
- The manuscript is not subject to the employee work regime, its use under the licence used by the Acta Musealia journal is not restricted by the terms of any specific financial support (e.g. grant) or by the rights of any third party. If sources of financial support have been used in the preparation of the paper, these sources must be acknowledged in the paper. If third-party materials have been used, the author declares that he/she has obtained the necessary permissions before submitting the manuscript to the editors.
- The author agrees that if the manuscript is accepted for publication, a proposal for a licence agreement will be made on his/her behalf to an unspecified number of persons, the content of which will be determined by reference to the publicly available Creative Commons License CC BY-NC 4.0 International (full text available at: <https://creativecommons.org/licenses/by-nc/4.0/>) this proposal for a licence agreement will not be made for works or components (e.g. visual or photographic documentation) used by the author in the paper under a contractual licence with a third party.

Granting of a licence
